

CHECKLIST: VISIT FAMILY IN NORWAY (Please, submit documents in this order)

DOCUMENTS FROM THE THAI APPLICANT:

Please check the boxes below and sign to confirm which documents you have submitted:

- Passport photo** (not older than three months old, 2 inches in size, white background, with no glasses and glued to the application form).
- Passport** (both new and old passport(s) if any).
- Copy of the applicant's passport** (Place and date of issue, expiration date, previous visas, valid resident/work permit in Thailand etc).
- Copy of all relevant pages of Household Registration, and/- or other documents proving the family relation with the reference person in Norway.**
- Documents confirming employment, private business, school or studies; a permission for leave of absence**
- Copy of bank account(s) for the last 6 months** (bring also original)
(If insufficient, a guarantee form from reference in Norway needs to be submitted; see information below.)
- Confirmed booking of roundtrip air ticket, with fixed travel dates of maximum 90 days.** (Do not buy the ticket until a visa has been granted. Note: If the application is approved, the visa will be issued according to the dates on the booking).
- Compulsory travel medical insurance, covering all Schengen countries,** (see separate information)
- If you are under 20, you must also submit:**
 - If you are travelling alone: An original and a copy of letter of consent signed by both parents, stamped by Amphur
 - If you are travelling with only one of your parents: An original and a copy of letter of consent from the other parent, stamped by Amphur
 - If the parent you are travelling with has single custody: A shown original and a copy of certificate of single custody
- Please contact the Embassy about special rules for minors under 18 years intending to visit parent living in Norway**
- Optional for applicants who want the reference person or other person to represent them in the case: Letter of Power of Attorney** (Separate form is obtainable at the Embassy).

DOCUMENTS FROM FAMILY MEMBER IN NORWAY:

- Invitation letter from family member stating the purpose of the visit. The invitation letter must be original and signed by the reference person.
- Copy of relevant pages of the reference person's passport (showing Norwegian work or residence permit), and/- or copy of the guarantor's passport

The documents below are only required if the applicant does not have documents proving sustainable economic means or income:

- Original guarantee form for visits stamped by Norwegian authorities + 1 copy**
- Documentation of income** (by copy of last month's pay slip and/- or employment contract and the last available tax receipt (ligningsattest).

NOTE: Documentation from the reference person must be sent by **regular or express mail directly** to the applicant, and not by fax or as a scanned attachment to e-mail.
