

ENTRY VISA FOR SPOUSE

Thai citizens married to Norwegian citizens can apply for an entry visa to Norway with the purpose of applying for residence permit in Norway. The application must be submitted at the Norwegian Embassy in Bangkok. An entry visa ensures valid stay for a seven days period, in which an application for a residence permit has to be submitted to the local police district. For complete regulations see UDI RS 2010 –003 (www.udi.no).

The following documentation is required:

Please check the boxes below and sign to confirm which documents you have submitted

- Cover letter** from the Application Portal (signed by the applicant) +1 copy
- Passport photo** (not older than 3 months, 2 inches in size, white background, with no glasses and glued to the cover letter.)
- Original and copy of all pages of the applicant’s passport** (Place and date of issue, expiration date, previous visas to the Schengen areas and other countries, valid resident/- work permits etc.)
- Original and copy of previous passports** (if any)

Documentation from the Norwegian spouse:

- Copy of all pages of passport** (Place and date of issue, expiration date, pages showing previous visits to Thailand (entry/exit stamps).
- A written statement from the Norwegian spouse** (in Norwegian) explaining the relationship between the two parties prior to entering into marriage. This letter should be as detailed as possible.
- Divorce certificate or death certificate**, if previously married. If the Norwegian spouse has previously been married to a foreign citizen, and this spouse had a permit in family immigration in Norway, the Norwegian spouse must present documentation that the first marriage has been dissolved in the previous spouse’s home country, or the country where the marriage was entered into.
- Documentation of housing** (sale or rental contract)
- Documentation of income.** The documentation must show **former and future income** (by copy of three recent pay slips and employment contract and the last available tax receipt (ligningsattest). The minimum requirement is equivalent to civil service pay grade 8, which is NOK 217.600 per year. Documentation showing that the applicant’s spouse **has not received social benefits the last 12 months** must also be submitted (by a written confirmation from The Norwegian Labour and Welfare Administration (NAV) in Norway).
- Photos documenting the relationship;** may be submitted if you think that they are important to substantiate that the relationship is genuine

Documentation from the applicant presented to the Embassy:

- Verified translation and copy of Marriage Certificate***
- Verified translation and copy of Marriage Registration***
- Verified translation and copy of ID-card ***
- Verified translation and copy of all pages of Household Registration ***
- Verified translation and copy of Birth certificate ***
- Verified translation and copy of documentation proving change of name (if any) ***
- Verified translation and copy of documentation proving dissolving of previous marriage (if any) ***
- If you are under 20, you must also submit a verified translation and copy of a letter of consent signed by both parents ***

*** The translation shall be into English and the verification made by Thai Ministry of Foreign Affairs**
Supporting documentation must be submitted together with the application, by the applicant personally. Supporting documentation sent to the Embassy without reference to a registered application will not be considered, and made waste. We urge the applicant to take care when completing the application form and to include all the requested documentation as the application may be refused if the documentation submitted is incomplete.

I hereby confirm that I personally have submitted this application for an entry visa and that all information stated in the application and the supporting documentation is true. I am aware that providing incorrect information or falsified documents deliberately are punishable acts by both Thai and Norwegian law.
